Action Items

Approval of Preliminary Budget

Rev Thom, Andrew Wright

7:15-7:35 pm

- Draft budget for next fiscal year circulated to BOT after March meeting
- Budget will need some revisions
- Thom has met with HR committee. All staff are being slotted at the midpoint of the UUA range appropriate to them.
- Raising building and grounds budget line.
- Pledge income currently above goal. May be able to budget off of \$650K rather than \$630K in pledges. If so, will allow increase to facilities, increase Thom's salary, and decrease deficit.
- Overall budget looks good, we are in great shape. No worries on part of Thom.
- No additions from Andrew. Support for suggestions about how to allocate any further increases in pledges.
- Note that acoustic work and parking lot repaving came out of capital and maintenance reserve funds, not operating fund. Even after parking lot repaving, maintenance reserve fund balance is still positive. Capital fund balance is also still positive after paying for acoustics work.
- Endowment fund is planning to contribute additional \$9,000 to capital fund.
- Basketball parking income is on special funds (immigrant justice...) and does not appear on the operating budget
- Parking income is taxable, that is why we have tax payments on parking income
- Process:
 - No vote at this time. BOT must approve draft budget in June. Best practice to hold budget town hall before June meeting. Strong recommendation to circulate budget or make it available before the budget town hall.
 - BOT votes on final budget in September after current fiscal year closes.

- o Andrew and Thom will collaborate on scheduling budget town hall. After May and before June BOT meetings.
- o June annual meeting on June 18th.

Review 3rd Q financials

- Doing very well on pledge and other income.
- Expenses running higher than budgeted for first time since Thom has been here. Benefits somewhat higher than projected. Building maintenance and utilities are running higher likely because pandemic era savings are ending and that wasn't anticipated in the budgeting. Overall expenses are 76% through March (9 months of fiscal year) compared to goal 75%.
- Barb to write announcement thanking Endowment Committee for support of capital fund (acoustics? Other furnishings?)
- Endowment committee: \$8K available this year. Do we have an ask?
 - o Church sign?
 - o Internship?
 - o Potentially combine with discussion about kast estate at BOT retreat? If so, should let Endowment know (Glenn).
 - o Consider reviewing priorities lists for capital funds and for maintenance reserves as part of this discussion
