Appoint Members of the Committee on Ministry Rev. Thom Belote

Four of six members have agreed: Kari Andrade, Adam Rosen, Bonnie Gilliam, Susan Blanchard.

Candidates for the remaining two slots pending.

Policy says committee should be six members. Term of three years.

Responsibility: To hold the ministry of the church in care; be sounding board to Thom and help Thom focus on key priorities; annual evaluation of minister; mediation role as needed.

Approve Current FY Final Budget

Andrew Wright/Rev Thom Belote

On track to essentially break even from 2022-2023 fiscal year.

2023-24 proposed budget projects deficit as past years have done; we budget conservatively; expectation that budget will end up breaking even.

Set asides:

- Operating reserves required at least 6% of expenses in reserves; currently at 12%.
- Maintenance reserves annually put in 7% of income in maintenance reserves for large maintenance projects >\$1,000 and typically much larger (parking lot, Manse sewer repair, HVAC). Good balance now, expected to be quite low after completing sanctuary project of painting and replacing floor.
 - Previously shared that a greater contribution to maintenance reserves will be needed in the not too distant future. No specific plan for that now. Pending firmer estimates of sanctuary costs.
- Ministerial reserves. Currently ~\$11,000. To be used if minister leaves interim minister, search committee costs, or for sabbatical minister. In future, good to contribute further to this fund. Last ministerial search cost \$15,000.
 - Costs for ordinations paid for from minister's discretionary fund and worship fund.
