#### **Discussion and Planning**

Immigrant Justice Initiative Update - Merry K Moos 7:25 – 7:40

#### Formed in 2017.

First guest in 2019.

Short term and long term housing to a range of people. Contacted by a range of partners about new guests.

Short term work primarily with refugees supported by agencies.

Principal work is with immigrant families who are seeking asylum with wide ranging needs, no resources, and history of trauma.

Work to find lawyers to work with them through the asylum process. Work permits. Other agencies.

Long term commitment that lasts beyond residence in the Manse.

Many many volunteers and volunteer hours.

Manse is central to IJI work to provide housing.

Support from church operational budget is critical.

## Where do guests go after leaving Manse?

- One family earned / saved enough to rent townhouse.
- Another is now living with family. Still providing some support.
- A third is earning enough to rent her own apartment.
- All continue to receive a great deal of support from IJI some financial but much more in other ways.

**Guests not from Latin America? Translation challenges?** 

- One Afghani family translation was a challenge.
- One Syrian woman spoke English well.

Substantial donation of pro bono dental and medical care from various providers.

Operation of Manse (utilities, maintenance) paid from operational budget of church.

IJI receiving calls from Orange County about use of Manse – recognized as leader.

Always a need for more Spanish speakers as translators!

Great team for BOT service project – team of 15 or so, lots of work done at Charles House. Music organization project. 18 project, 250 volunteers. Pictures gathered and posted on church website.

Future recommendations: No rain date. Would have been very difficult to reschedule most of these projects, and many could have gone on rain or shine.

Estimated budget of \$1,500, only spent \$868. Food, decorations, child care.

Last year: Total pledge was \$675,000 from 327 pledges. Budget based on \$650,000.

Goal for this year: \$725,000.

This year: Two-thirds of members responded by March 3<sup>rd</sup>. At 80% of goal currently. Amount raised to date: \$615,909. Many members increased their pledges.

In outreach phase to those who have not pledged. Outreach from staff, Bonnie depending on person.

Funding increase priorities for 2024-25 budget

- Increase utilities
- Increase maintenance reserves

- Decrease budgeted deficit
- Cost of living increase for staff
- Wage rate increase for youth staff
- Additional professional development funds for Marion and Kat
- Additional hours for Kat to allow Marion a mini-sabbatical

What about Manse? Brad's proposal for needed improvements.

• That will come from maintenance reserves over next ten years.

Does church pay taxes on pledges received?

- No.
- Church does pay tax on Mon-Fri 9-5 parking lot income but not on after-hours special events parking.
