- Board retreat focus on Strategic Plan
  - o Development of new strategic plan

- How will we engage congregation?
- How do we put the long-term plan into action?
- Strategic plan must work with culture of church
- Not about next year's needs and budget
- What will scope of next strategic plan be? 3 years, 5 years, 10 years? Impacts amount of work, what plan encompasses.
- o Board policy book, page 10: Definitions of Strategic Plan and Annual Vision of Ministry
- o Key points from "The Truth About Strategic Plans" discussed
- o Our church's mission guides everything we do
- Board was very productive and successful in 2022
- o Need "plan for good" for 2023, in particular in thinking intentionally about charlie kast gift
- Notes reviewed from October 2022 meeting when Board members identified pending / unaddressed items from the year, on the list as goals for 2023
- o charlie kast bequest: Commitment made for buildings & grounds, long-term maintenance to be top considerations, but final decisions not made
- Considerations about timing for Board retreat has traditionally been in January but doesn't need to be
- Scheduling? Glenn to send email after meeting about scheduling input and activities / agenda items

## • charlie kast bequest

- Original gift was \$235,000 in March 2021: \$150,000 to capital campaign to close gap; \$50,000 to endowment;
   \$35,000 seed money for capital fund
- Upon charlie's death: In November 2022, \$176,284 gift to church. \$100,000 designated by BOT to pay for parking lot repaving. \$76,284 remains in hand.
- charlie's estate still in probate; when settled, additional gift will be made to church. End of probate may be end of February. Additional amount not finalized.
- o Perceived / possible funding needs
  - Maintenance reserves? Significant upcoming needs: paint, water damage repairs, HVAC
  - Intern fund named for charlie?
  - Capital fund?
  - Special program in remembrance of charlie?
- Initial board member reactions:

- Would hate for it all to be spent on paint etc. At least one piece on something really memorable for charlie.
- Another naming opportunity?
- Sanctuary and stage refurbishing as very visible capital improvement?
- Component that is not "stuff" is appealing
- Funding of maintenance reserves is very important
- Buildings & Grounds presents 10-year financial needs plan to BOT annually upcoming may want to delay taking into consideration timing of BOT retreat
- Appealing for part of kast money to go to something memorable. But a question are these one-time funds the program would then end or would such a program be sustainable?
- Meaningful to have something that will honor charlie's memory to future generations. Honor his wishes. Name a room?
- charlie had several interns while minister clearly very important to him. Internship would potentially honor his memory more than speakership series. Conversations during preparation of will: delighted to have funds go toward capital campaign. Maintenance needs were also very important. Not clear that naming (e.g. room) would have been particularly important to him.
- Should large maintenance needs be funded through large one-time gifts such as this, or through annual adequate funding of the maintenance reserves?
- "Imagine a plan for unexpected futures."

# • Specific internship proposal for 2023

- o In November, Rev. Thom presented preliminary information to BOT about a potential candidate for an internship, and BOT authorized Thom to explore possibility further
- o Rev. Thom presented more detailed proposal to offer internship to candidate
- Cost would be approximately \$30,000 for one-year full-time or \$38,000 over two years for two years part-time (more likely scenario)
- o Internship is essentially "full immersion" experience intern does all the things the minister does: preaching; board and committees; caring ministry; classes; social justice; groups / programs
- o Pros and cons of one- vs. two-year internship discussed. Seems likely to be two years, will generally be dictated by seminary.
- o Straw poll regarding support for internship, pending financial discussion
  - Strong support

- > Finance: Treasurer cautions against proceeding without intention to at least partially fund from kast bequest. Would be possible to fully fund from operating budget but would stress operating budget.
  - Lots of other funding streams possible. Share the Plate, ...
- o Straw poll support to at least partially fund from kast bequest
  - Strong support
  - Based on this support, Treasurer is comfortable recommending that the BOT proceed with motion

**Motion:** The Board of Trustees authorizes Rev. Thom Belote to offer an Internship to Jenn Kapranov beginning in the fall of 2023. Further, the Board authorizes Rev. Thom to offer the Intern a salary and benefits package not to exceed \$30,000 for a one-year, full-time internship or \$38,000 for a two-year, part-time internship.

Motion to authorize Rev. Thom to offer internship to Jenn Kapranov starting in fall 2023 moved by Barb, seconded by Joe, passed unanimously
